- No more than four words and eighteen letters (including spaces between words).
- Words may be strung together without spaces. Example: "NAMETHEHORSEANDWIN"
- Not allowed: Proper names of famous people, famous racehorses, products, companies, etc. May not use "Mr., Miss, Mrs, Jr." unless it is part of the Sire or Dam name. No inappropriate language or references.
- Allowed: Titles or popular phrases from books, songs, films, etc. Entry does not need to contain parts of Sire or Dam names – the name can be entirely original.

Any decision regarding the health of the Racehorse or the entry of the Racehorse into any race will be at the absolute discretion of the owner, the trainer of the Racehorse, or the relevant racing authority.
- The prize winner will not be permitted access to the Racehorse at any time, except as allowed by the owner or trainer at their complete discretion at any race meetings in which the Racehorse runs.
